- 51% Black Ownership - Automatic 125% B-BBEE Procurement Recognition Status **(Level 2)**
- 100% Black Ownership - Automatic 135% B-BBEE Procurement Recognition Status **(Level 1)**

QSE (Qualifying Small Enterprise)

with a turnover of R10m to R50m per year

B-BBEE Requirements:

- Full BEE audit on all 5 B-BBEE scorecard elements unless:
- 51% Black Ownership - Automatic 125% B-BBEE Procurement Recognition Status **(Level 2)**
- 100% Black Ownership - Automatic 135% B-BBEE Procurement Recognition Status **(Level 1)**

Generic Company

with a turnover of R50m and above per year

B-BBEE Requirements:

- All 5 B-BBEE Scorecard elements are compulsory regardless of black ownership levels
- Compliance on each level is awarded points and compulsory
- Final point score determines the B-BBEE status level
